		Customer will be charged monthly to the credit card on file for chemicals, parts, and charges associated with maintaining pool.		
	Payment Pl	an (check box if choosing this option)		
		Payment plans are assessed a \$75.00 finance charge.		
		There will be 6 monthly payments of \$412.50		
		Chemicals, parts, and charges associated with maintaining the pool will be added to Customer's monthly payment.		
	Caveats			
		The Spa Weekly Service Contract will not start until we have a signed Contract WITH a valid credit card on file.  Should a credit card payment not go through, service will stop immediately and can		
		only resume with payment.		
		Chemicals are NOT included and billed in accordance with the pricing matrix above.		
		Paradise is authorized to add chemicals, perform minor repairs, and to replace parts that cost up to \$50.00, i.e., O-rings, drain plugs, skimmer baskets and other simple parts.		
		Any repairs or parts needed over \$50.00 will be discussed with the Customer. A free estimate will be provided, as well.		
		Visits not used are nonrefundable.		
		If the Customer terminates this Contract prior to us closing the pool, the Customer is responsible for visits, parts, and chemicals used up to date of termination, as well as a		
		\$150.00 cancellation fee.  If the Customer refuses to pay for any services, chemicals, parts, and/or fees, the Customer will be responsible for any and all collection or legal fees that Paradise Pool & Spa incurs attempting to collect payment.  The Customer's account balance must be paid in full prior to pool closing, or Paradise		
		Pool & Spa will not close your pool.
